IHDA, LLC reserves the right to refuse, correct or cancel for cause this litter registration. Any misrepresentation on this application is one example of “for cause” cancellation and may result in loss of IHDA privileges.

Any application for which all information and supporting documentation has not been supplied in a timely manner will be considered to be “incomplete” and may be returned to the litter owner.

Both parents must be registered with International Herding Dog Association or application for registration of parent(s) must be included with litter application.

- **Litter and 2 parents registration - \$65.00**

- All dam and sire owner(s) or lessee(s) and litter owner(s) or lessee(s), if different than dam owner, MUST sign the application.
- **The litter owner is defined as the owner or lessee of the dam at time of whelping. The breeder is defined as the owner or lessee of the dam at time of mating.**
- The only lease accepted will be those issued by IHDA, LLC.
- If registering either 1 or both parents at time of litter application, include the registration application (s) and a copy of the registration certificate that the dog is currently registered with.

Pedigree Verification Process

Verification of generations is done using copies of registration certificates and/or certified pedigrees issued by acceptable registries as listed above. In some instances, IHDA may already have these documents and therefore some of the dogs in a pedigree may already be verified. However, in many instances IHDA does not have any information on dogs within a pedigree especially if the dog is registered with another registry. IHDA does not have access to other registries' databases. Therefore, the only way verification can occur is to have an official document, as described above, to verify not only a dog's registered name and registration number but to also verify that dog's connection (parent, grandparent, or great-grandparent) to the dog. You will not be able to order a Certified Pedigree if we do not have 3 generations of verified dogs in our system.
